LIABILITY WAIVER AND RELEASE

This Liability Waiver and Release (the "Waiver") is entered into by and between the undersigned individual(s) and/or organizations (the "Participant(s)") and Lost Bridge Community Church (the "Church"). By signing this Waiver, the Participant(s) acknowledges and agrees to the following:

Assumption of Risk

The Participant(s) understands and acknowledges that participating in an event at the Church, including the Church grounds and/or Chapel House, may involve certain risks, including but not limited to personal injury, property damage, or loss. The Participant(s) voluntarily assumes all risks associated with such activities.

Release of Liability

The Participant(s), on behalf of themselves, their heirs, representatives, and assigns, hereby releases, waives, and forever discharges the Church, its officers, congregants, employees, volunteers, and affiliates from any and all claims, liabilities, demands, actions, or causes of action whatsoever arising out of or related to any loss, damage, injury, or harm sustained in connection with use of Church facilities.

Indemnification

The Participant(s) agrees to indemnify and hold harmless the Church from any claims, damages, liabilities, costs, or expenses (including attorney's fees) arising from their use of the Church's facilities or participation in any event-related activities. The Participant(s) further assumes responsibility for the actions and conduct of their guests, including any damage or injury caused by them.

Property Damage

The Participant(s) agrees to be financially responsible for any damage to the Church's property, facilities, or equipment caused by themselves, their guests, or vendors used for the event.

Compliance with Rules

The Participant(s) agrees to abide by all rules, regulations, and policies established by the Church for the use of its facilities and acknowledges that failure to do so may result in termination of the event without refund. Rules and regulations may be communicated either orally or in writing, or both.

Medical Treatment

In the event of an injury or medical emergency, the Participant(s) consents to receive emergency medical treatment deemed necessary and releases the Church from any liability related to receiving such treatment or failure to seek said medical treatment.

Photography and Media Release

The Participant(s) acknowledges that the Church may take photographs or recordings during the event for promotional or archival purposes and grants permission for such use unless otherwise stated in writing.

Severability

If any provision of this Waiver is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

Jurisdiction

This Waiver shall be governed by and construed in accordance with the laws of the State of Arkansas. Any legal proceedings arising from or related to this Waiver shall take place in Benton County, Arkansas.

Acknowledgment of Understanding

The Participant(s) has read and understands this Waiver and signs it voluntarily with full knowledge of its contents and significance.

By signing this Waiver, Participant(s) agrees to the terms stated within and attests that if Participant(s) is signing on behalf of an Organization, Participant(s) has been authorized to do so. If Participant(s) is under 18 years old, a parent or legal guardian must also sign. If the event is a wedding, both Bride and Groom must sign the document.
